

In the spring semester 2011, six students in Agricultural and Applied Economics, **Jennie Allison, Zeke Bryant, Philip Klayman, Gena Perry, Nicholas Pisarello,** and **Travis Voyles**, prepared to compete in the SAEA's Academic Quiz Bowl by taking a class in applied agricultural economics topics led by J. Wesley Burnett and Glenn C. W. Ames, doctoral student and professor, respectively. The Quiz Bowl format mixes students from other association universities into teams of three who compete against each other and the clock. Moderators read from a test bank of questions on micro and macro economic theory, agribusiness, quantitative methods, resource policy, management, and potpourri. Graduate Student Spotlight



J. Wesley Burnett



J. Wesley Burnett, a fourth-year Ph.D. candidate in the Department of Agricultural and Applied Economics, is from Atlanta, Georgia. His concentration is in environmental and natural resource economics. Wesley holds a B.A. from the College of Charleston, Charleston, SC and an M.S. from the University of Georgia.

Wesley has proven to be an excellent student during his years in the department. In 2010, he was selected as the Outstanding Ph.D. Student in the department, and he received the Outstanding Ph.D. Paper Award. He is the recipient of an Agricultural and Applied

Economics Association travel grant, and he was selected to present a graduate student invited paper at the Southern Economics Association meeting this year. He also traveled to Denver, CO twice this year to present a paper at the North American Regional Science Committee meeting and poster at the Agricultural and Applied Economics Association meeting.

From 2007 through 2008, Wesley served as president of the university-wide Graduate Student Association where he represented the 8,000 graduate and professional students on campus. He is a current member of the department's Graduate Student Association. He is also a member of the Agricultural and Applied Economics Association, the Southern Agricultural Economics Association, the Southern Economics Association, and the North American Regional Science Committee.

Wesley is a graduate research assistant working in collaboration with Drs. John Bergstrom and Michael Wetzstein. He is also currently teaching an upper-class special topics course in the department and serves as one of the captains

of the undergraduate Quiz Bowl Team.

Regarding his experiences in the department, Wesley stated, "The course-work is obviously helpful in preparing for a career, but honestly, the intangible skills that I learned in the department are almost as equally important. My mentors have taught me how to navigate the entire academic process from student to professional economist."

Wesley plans to complete his Ph.D. program early in 2011. After graduation, he hopes to acquire work conducting research in the areas of energy, environmental, and natural resource economics.

When asked what advice he has for current students in the department, Wesley stated, "There's always a 'vice' in every bit of 'advice,' but I would probably tell them to take it easy and enjoy the experience. In hindsight, I was overly eager to produce research and put too much pressure on myself. It would have benefitted me greatly to enjoy the student experience a little more."

In his spare time, Wesley does some volunteer work with the Food Bank of Northeast Georgia. He enjoys cooking, reading, boxing, tennis, disc golf, yoga, tent camping, and other outdoor activities. Faculty Spotlight



Dr. Stanley Fletcher



Dr. Stanley Fletcher is a professor in the Department of Agricultural and Applied Economics, working at the Griffin Campus. He joined the department in 1979 when he began his career as an assistant professor. In 1985, he was promoted to associate professor, and in 1993, he was promoted to professor. During the entire 32 years of Dr. Fletcher's employment at the university, he has been a very committed and proactive faculty member.

Dr. Fletcher is the author or co-author of more than 475 publications, many of which were refereed. He has conducted a vast amount of research and has been a principal or co-principal investigator on grants totaling \$6,853,376 and a cooperator on grants totaling \$10,849,686. He

is nationally and internationally known for his expertise in all things pertaining to peanuts. He has prepared and made more than 490 presentations to professional and industry groups, a number of which were invited. On several occasions, Dr. Fletcher has been invited to present testimony related to various Farm Bills to the Senate and U.S. House Agriculture Subcommittees and data to be used in testimony before the House Subcommittee on Small Business. In addition, he has been called countless times by USDA personnel regarding peanut economic policy, trade, and marketing issues, and he has been interviewed numerous times by radio and television hosts on these topics.

Dean Scott Angle, along with the peanut industry leaders, requested that Dr. Fletcher lead and coordinate the industry-wide farmers' stock peanuts grading project. Dr. Fletcher had the task of enhancing and changing the system that had been in place since the 1950s with a goal of meeting the needs of the 21st century's global environment and competition.

Dr. Fletcher is the only economist elected as a Fellow for the American Peanut Research and Education Society. Also included in the impressive list of Dr. Fletcher's awards are the 2006 APRES Dow AgroSciences Award for Excellence in Education, the 2005 Georgia Peanut Distinguished Service Award, the 2004 APRES Dow AgroSciences Award for Excellence in Research, the 2004 American Peanut Council's Peanut Research and Education Award, the 2002 Gamma Sigma Delta Senior Faculty Award, and the 1999 Presidential Award for Excellence in Research and Communication.

Dr. Fletcher plans to retire from the university in April, but he will continue his important work with the peanut industry.

Research Spotlight

Dr. John C. Bergstrom



Dr. John C. Bergstrom was named the first Richard B. Russell Distinguished Professor of Public Policy in 2005. He joined the faculty of the University of Georgia on January 1, 1987 after completing his Ph.D. in Agricultural Economics at Texas A&M University in 1986. He earned an M.S. in agricultural economics from Clemson University in 1982 and a B.S. in conservation and resource management from the University of Maryland in 1979. In his roles as Russell Professor of Public Policy and Professor of Agricultural and Applied Economics, Dr. Bergstrom's research, teaching, and outreach programs focus on developing concepts and techniques for assessing natural resource and agricultural values and applying these values to resource and agricultural public policy and management.

Dr. Bergstrom's expertise and accomplishments have been recognized nationally and internationally through professional publications and presentations, research and outreach contracts and grants, teaching and curriculum development, and service as a technical advisor and consultant. His research record includes over one hundred refereed professional publications and over \$3 million in research contracts and grants, with most of these funds received from the USDA to support projects assessing natural resource and agricultural values and the application of these values to inform public policy and management. Many of the research contracts and grants received by Dr. Bergstrom are provided by agencies, organizations, and firms to address specific public policy problems and issues. Research results are therefore directly applied with Dr. Bergstrom's technical assistance to solve pressing natural resource, environmental, and agricultural policy issues. Dr. Bergstrom's research program and expertise in natural resource and agricultural valuation has also been recognized over his career at UGA through speaking invitations at various professional and public service meetings and his work as a technical consultant for federal, state, and local government agencies, non-profit organizations and private firms.

Dr. Bergstrom's research has strong public service and outreach connections and impacts. He works extensively with research clients to transfer and apply research results to practical public policy analysis, assessment and decision-making. He is often called upon by federal, state, and local government agencies, private non-governmental organizations, private firms, and private landowners and firms to provide advice and consultation on resource, environmental and agricultural valuation, policy, and management. Dr. Bergstrom is also currently working with individual farmers and landowners in Georgia to help develop strategies and funding proposals for preserving their farms through conservation easements. Dr. Bergstrom also teaches undergraduate and graduate courses in natural resource and environmental economics and policy, coordinates the undergraduate environmental economics and management internship program, and coordinates the department and graduate student seminar series. In addition, he serves as an undergraduate and graduate student advisor and mentor for the AAEC Department and the UGA Honors Program.

Faculty News

Banana News in Georgia



Americans consume 33 pounds of bananas per person every year, and 99 percent of all bananas eaten in the U.S. come from other countries.



Dr. Greg Fonsah, head of the UGA Banana Project, and a team of researchers has been investigating 35 banana varieties in Georgia since 2003. Dr. Fonsah is hopeful that bananas could be much like strawberries or blueberries, which have both turned

into multi-million dollar crops in Georgia in the past few decades. He stated, "It will be our new commodity, and at least part of that \$1.5 billion spent to import bananas to the United States would be going back to boost our economy."

According to Dr. Fonsah, the Veinte Cohol banana variety, which was discovered in Florida, looks promising as a Georgia crop. Like all bananas, the variety does not tolerate cold temperatures, but it is a short-cycle banana which grows well in Georgia and the Southeast. Most bananas need to mature on the tree for three months before harvest, but the Veinte Cohol variety can be planted in April and harvested in October before killing frosts reach the southern part of the state. Compared to the Cavendish, the favored variety in the U.S., Veinte Cohol bananas are smaller and tangier with a slight citrus flavor.

Alumni Spotlight

Dr. Steven Cornell Turner



Dr. Steven Cornell Turner is a professor and head of the Department of Agricultural Economics at Mississippi State University (MSU). He was recently recognized for significant contributions to his field with the 2011 Southern Agricultural Economics Association's (SAEA) Lifetime Achievement Award at the association's annual meeting in Corpus Christi, Texas. The interim dean of MSU's College of Agriculture and Life Sciences, George Hopper, stated, "Turner's personal commitment to academics, volunteerism, and professional organizations is an asset to the university community." Dr. John Lee who is the former head of MSU's Department of Agricultural Economics nominated Dr. Turner for the award. He stated, "As department head, Dr. Turner has demonstrated an ability to attract top faculty, inspire successful grantsmanship,

raise academic standards and initiate new degree programs.....He also has maintained a high level of faculty and staff morale in the face of major budget challenges." Dr. Turner is an outstanding educator whose career has been balanced with quality productivity in research, teaching, and service. He has gained a national reputation through service with national and regional organizations and an array of outstanding accomplishments in teaching, research, and various service activities.

Dr. Turner's outstanding reputation earned him the position of Chair of the Board of Directors of the Council on Food, Agricultural and Resource Economics (C-FARE) in Washington, D.C. He is still active in the organization, which works to identify key economic issues, establish priorities, and seeks support for research, extension and academic instruction. The organization collaborates with other professional organizations to foster support for agricultural research and publicize agricultural economics contributions to solving important societal issues.

Dr. Turner received his B.A. in English Literature from Mercer University in 1975, his M.S. in agricultural economics from the University of Georgia in 1981, and his Ph.D. in agricultural economics from Virginia Polytechnic Institute and State University in 1986. From 1979 through 1981, he worked as a research assistant in the Department of Agricultural and Applied Economics at the University of Georgia while pursuing his M.S. He then worked as a research associate/assistant in the Agricultural Economics Department at Virginia Polytechnic Institute and State University while he earned his Ph.D. Upon receiving his Ph.D., Dr. Turner returned to the Department of Agricultural and Applied Economics at U.G.A. as an assistant professor and was promoted to associate professor in 1993. After being promoted to professor in 2003, he was offered his current position at Mississippi State University.

As the Agricultural and Applied Economics Department's undergraduate coordinator for a number of years, Dr. Turner provided effective leadership for curriculum development and management and student recruitment for three majors — agricultural economics, agribusiness, and environmental economics and management. Providing outstanding support to various student groups and clubs at UGA, he served as advisor for the Agricultural and Environmental Economics Club and to the student chapter of the National Agri-Marketing Association (NAMA).

His extraordinary service to NAMA earned him the respect of students across the nation. This resulted in his being elected by students in agricultural economics clubs nationwide to serve as faculty advisor to the student section of the American Agricultural Economics Association (AAEA). He served in this position from 1991 to 1994. These

clubs now rank among the most active and competitive clubs in the nation.

In 2000, Dr. Turner was elected to serve as president of the Southern Agricultural Economics Association (SAEA). He has provided significant service to both SAEA and the American Agricultural Economics Association (AAEA) as faculty advisor to the student section, directing the teaching workshop, initiating the Academic Bowl and Graduate Student Fair, and elevating the importance of students and teaching within both organizations.

During his seventeen years as a faculty member at UGA, Dr. Turner became widely known for being a gifted and effective teacher, highly supportive of his students, imaginative, and caring. He advised and accompanied students as they participated in NAMA and College Bowl competitions which provided excellent learning experiences. He consistently enjoyed excellent teacher evaluations and was generally recognized by students as an outstanding advisor. Dedicated to professional development and improvement of classroom teaching, he served on numerous committees related to teaching, including serving as chair of the UGA Instructional Advisory Committee in 2000 and 2001. He was one of the first Lilly Fellows and is a Senior Teaching Fellow. In 2001, he was inducted into UGA's Teaching Academy and served as a leader in the development of a national network of teachers of agricultural marketing.

On numerous occasions, Dr. Turner was recognized by exiting seniors as among the best teachers in the department. He has an impressive list of awards documenting his outstanding teaching qualifications, including being named the department's Outstanding Undergraduate Teacher four times – 1987, 1991, 1995 and 1999. He has received numerous college and university teaching awards, including the D.W. Brooks Distinguished Faculty Award for Excellence in Teaching in 1991, the Agricultural Alumni Association Teaching Award in 1992, the American Agricultural Economics Association Distinguished Teaching Award in 1992, the Teaching Award of Merit in 1992, and Superior Teaching Recognition at the UGA Honors Day Convocation in 1992. He was recognized as one of the best undergraduate teachers at UGA with the Richard B. Russell Outstanding Undergraduate Teaching Award in 1993. In addition, he received the SAEA Distinguished Professional Contribution in the Teaching of a Course Award in 1996, the UGA Student Government Outstanding Teacher Award, and the Graduate Student Association's Outstanding Graduate Faculty Award in 2002.

Dr. Turner's career at UGA was also successful in the area of his research. With a 50% research appointment for most of his seventeen years at the university, he has an impressive publication record. He co-authored two books on futures markets and authored a chapter in a book on the teaching of economics. Additionally, he authored or co-authored at least thirty-one professional journal articles, seven bulletins or reports, thirty-five journal abstracts, twenty-six proceedings chapters, along with numerous other publications, and secured in excess of \$144,000 in educational and research grant funding during his years at UGA. He established a research program in marketing landscape plants and livestock, and he was among the first group of professors to conduct research on the economics of the green industry. In addition to his work in teaching and research, he served as a member and/or chair of countless committees during his years at the university.

The Department of Agricultural and Applied Economics at UGA would like to congratulate Dr. Steven Turner on his Lifetime Achievement Award and on his successful career.




