Graduate Student Spotlight

Ajita Atreya



Ajita Atreya is a fourth-year Ph.D. student from Kathmandu, Nepal majoring in agricultural economics. She entered the department's Ph.D. program in July of 2009. Ajita graduated summa cum laude with a B.S. in agriculture economics from the Institute of Agriculture and Animal Sciences, Tribhuvan University, Nepal, and magna cum laude with an M.S. in agricultural economics from Oklahoma State University.

Ajita was recently presented the 2012 Outstanding Ph.D. Student Award from the Department of Agricultural and Applied Economics, UGA.

She worked with Dr. Susana Ferreira on the USGS Georgia Water Resource Institute Research Grant and received the Innovative and Interdisciplinary Research Grant from the UGA Graduate School in 2011. Also in 2011, she received the UNICT-EAERE-FEEM Belpasso International Summer School Grant and a Foreign Travel Grant from the University of Georgia Research Foundation.

While at Oklahoma State University in 2008, Ajita received the Graduate College Research Fellowship from the Graduate School and the Spielman Scholarship from the Department of Agricultural Economics.

Ajita received the Scholarship of Merit from the Office of the Dean for the Institute of Agriculture and Animal Sciences, Nepal from 2002-2006 and the Nepal Vidhya Bhusan Chhatra Padak, a national award from the Ministry Education in Nepal in 2006.

Currently, Ajita is serving as vice president of the Nepalese Student Association at UGA. At Oklahoma State University, she served as treasurer of the Nepalese Student Association from 2008 through 2009 and as the Graduate and Professional Student Government Association representative for the Department of Agricultural Economics from 2007 through 2009.

She has given presentations at a number of professional conferences for the Agricultural and Applied Economics Association, the Southern Agricultural Economics Association, and others.

Ajita is currently working as a research assistant to Dr. Susana Ferreira and worked as a teaching assistant to Dr. Oz Kaya in her 2009 intermediate microeconomics class in the department and as a research assistant at Oklahoma State University during her years as an M.S. student.

Ajita's special interests include environmental economics, climate and land use change, and spatial econometrics. After completing her Ph.D., she would like to "get involved in a cutting-edge research career that can make a real difference in people's lives."

In her leisure, Ajita likes visiting new places and exploring new cultures. She enjoys playing volleyball, watching movies, and spending time with her family and friends.

Faculty Spotlight

Dr. Warren Kriesel



Dr. Warren Kriesel joined the Department of Agricultural and Applied Economics at UGA as an extension specialist on the Tifton Campus in 1988. He moved to Athens in 1991 and his time allocation is currently 55% research, 35% teaching, and 10% extension.

Dr. Kriesel specializes in analyzing the relationship between a region's economic prosperity and its natural resource base. Most recently, his research has focused on the coastal regions of Georgia. Using data from actual land transactions, his research shows that buyers bid up prices for properties that are located in subdivisions that have more open space and pervious surface.

Home-buyers' preferences for these property characteristics can even outweigh their preferences for large parcel sizes. Therefore, Dr. Kriesel's research indicates that developers of residential subdivisions have a market incentive to incorporate design features that reduce pollution of Georgia's saltwater marshlands. This is because pollutants are mainly transported by storm water runoff, and this is drastically reduced by these design features.

One of Dr. Kriesel's new projects will take these results and make them available on a website that uses GIS visualization technology. This work has been funded by SEA Grant, FEMA, and the Georgia Department of Natural Resources.

Dr. Kriesel teaches land economics and appraisal, applied econometrics, and rural economic development. In each of these courses, he utilizes real-world examples to motivate the thoughts of students. He especially enjoys teaching the land economics course.

When the course was previously taught, the concentration was on property appraisal. Graduates who wanted to work in appraisal had to take additional courses approved by the state licensing board. Dr. Kriesel gears the appraisal section of the course toward managerial uses, and the new land economics section covers areas not offered elsewhere in the university.

The focus of Dr. Kriesel's extension work is the website he developed and maintains for the Georgia Statistics System found at <u>www.georgiastats.uga.edu</u>. The website generates data, tables, maps, and graphs from a database of 1,400 variables for each of the state's 159 counties. The purpose of the site is to facilitate economic development by improving the information base available to decision-makers in local government, schools, and businesses.

Dr. Kriesel and his wife Sheila met while he was in graduate school at Virginia Tech, and they were married in 1984. Their oldest son, Frederick, was born in Tifton in 1990, and he currently works in the restaurant industry. Their son, Craig, was born in Macon in 1991, and he is a Corporal in the Marine Corps. Craig returned home safely from Afghanistan in March, and his ambition now is to be a normal college student.

The Kriesel's daughter, Maria, was born in Athens in 1995, and she will graduate from Oconee County High School next year. She plans to earn a degree in the life sciences from UGA. Maria has been on the track and field, cross country, and soccer teams. For the past three summers, she has worked as a counselor at BSA Camp Rainey Mountain. Maria serves as president of Venture Crew 149, and she backpacked at Philmont Boy Scout Ranch in Cimarron, New Mexico in June.

As a result of volunteering with the Boy Scouts of America, Dr. Kriesel discovered that he liked hiking and backpacking. He and his two sons spent two weeks backpacking at the Philmont Boy Scout Ranch in 2006. Since then, Dr. Kriesel has hiked one-third of the Appalachian Trail.

In addition to backpacking, he is now involved in mountaineering. He has been to the top of Athabasca, Alberta (11,800 ft.), Longs Peak, Colorado (14,300 ft.), Mt. Rainier, Washington (14,200 ft.), Mt. Blanc, France (16,000 ft.), and Aconcagua, Argentina (22,800 ft.). Dr. Kriesel describes mountaineering as being more of a mental than a physical challenge, involving self-discipline for staying in shape, and the mental focus needed for staying safe.

Outstanding Agricultural Economist Awards – Now Accepting Nominations




